Frey Ranch Distillery Receives Top Honor from NDA

Colby and Ashley Frey, pictured here with J.J. Goicoechea, Director of the Nevada Department of Agriculture were awarded last week with the NDA 2022 Nevada Agricultural Food and Beverage Small Business of the Year. This award recognizes the extraordinary work done by agriculture, food and beverage industries in Nevada.

The Frey Ranch Distillery's reputation is growing with the production of its award-winning bourbon and rye whiskeys. The release of their Single Barrel Rye, part of the ranch's celebration of this year's harvest, recently sold out after just a few weeks. They have also partnered with several local businesses to produce other whiskey-themed products and continue to support the local community as they take on the international whiskey scene, winning several prestigious awards.

The Frey's have had the first "Farm to Glass" operation in Nevada and are one of only four estate distilleries in the country. Their farm is a major tourist attraction for the community.

There were 15 nominees for this award in the ranching, food, manufacturing, and beverage company categories.

Obituaries

Dean Calkins

March 20, 1934 - January 23, 2023

Dean Calkins was one of the last true American cowboys of the Old West. Born in Kansas he helped his dad drive horse-drawn combines (5 abreast) during harvest season before the family eventually moved to Oregon. At the age of 17, Dean joined the Navy in 1952 during the Korean War where he served on a Landing Ship, Tank. He received the National Defense Service Medal, the United Nations Service Medal, and the Korean Service Medal (2 stars). He was honorably discharged in 1955.

After coming home, he earned his livelihood riding bulls, bare-back broncs, and saddle broncs on the rodeo circuit and was a life-time member of the Pro Rodeo Cowboys' Association. He drove truck to make ends meet and would often stop at farms and ranches along the way to do some trading. He was able to accumulate many wagons, harnesses and wagon wheels that farmers were no longer using.

After more than a few broken bones from riding broncs, Dean turned to coordinating and performing in Wild West shows. He would supply horses, crews, wagons, and some hair-raising stunts to the delight of many.

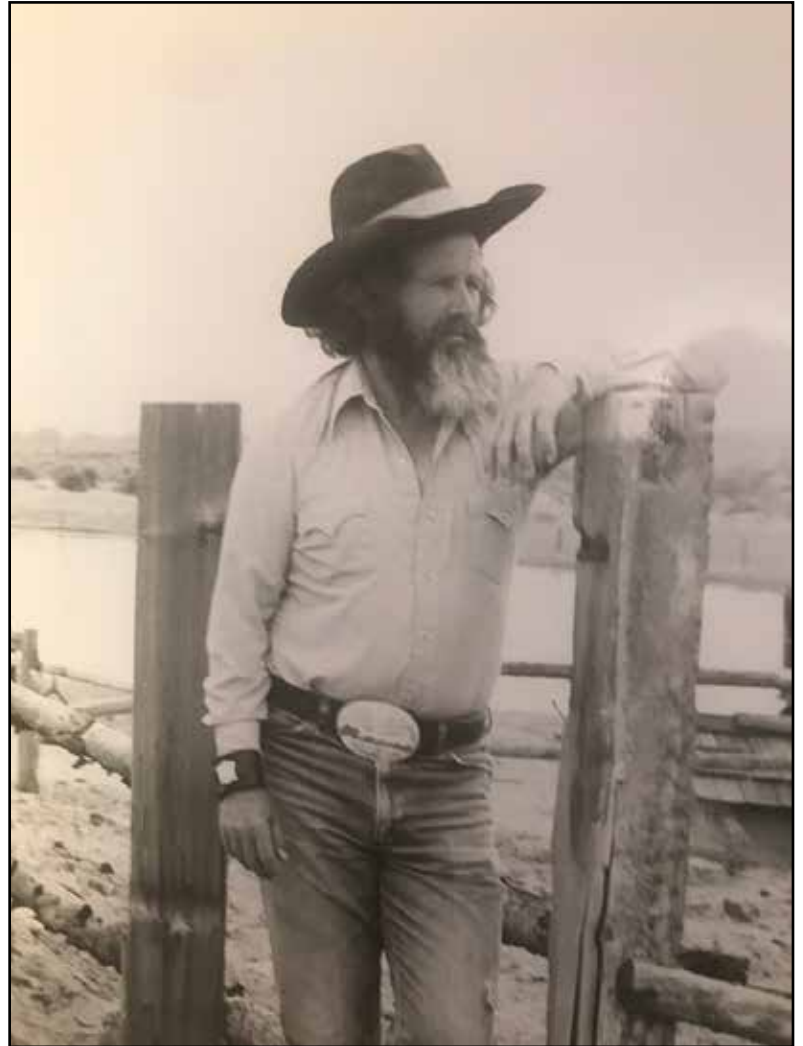
In 1985 he bought a ranch out by Lake Lahontan and built up a western town known as the C Bar D Film Ranch. It was the location of documentaries, commercials and a booming wagon train business. Dean became nationally known as an expert wagonmaster, horse trainer (training horses to harness), and owner and driver of one of the last authentic 20-horse hitches using a jerk line and voice commands.

After working on some stage productions he made his way into the film industry. Some of the more well-known

movie sets he worked on included: The Shootist with John Wayne, Honkytonk Man with Clint Eastwood, and Bonanza The Next Generation with Michael Landon, Jr. All totaled Dean was in over 60 films, documentaries, commercials, and stage shows. He was also a regular in the Reno Rodeo Parade and the Nevada Days Parade in Carson City.

Dean was most noted for his wagon train business, where people from all over the world would come to experience the Old West. Some of Dean's other accomplishments included: getting his pilot's license and eventually his own airplane; becoming a life-time member of the Screen Actors Guild; and teaching himself how to play the guitar and keyboard.

Dean Calkins was a man who accomplished much with what little he had. He was respected by many and deeply loved by his family. He is survived by his 3 daughters, Patty Kay Lim, Gail Sederquist, Christa Budinoff; his long-time



partner, Beverly Countryman; his brother, Vernon Calkins, 7 grandchildren, and 10 great-grandchildren.

Graveside services with military honors will be held on Friday, Feb. 3rd at 11:00 am at the Northern Nevada Veterans Cemetery in Fernley, NV under the direction of Smith Family Funeral Home (775) 423-2255.



State Government

Legislature Set to Begin on Monday

On Monday February 6 at 11am, both chambers of the Nevada Legislature will meet on their respective floors for the opening of the 82nd Legislative Session. There are many changes in this session not the least of which is the new Governor, Joe Lombardo and Lieutenant Governor Stavros Anthony, both Republicans. This means that the super majority held by Assembly Democrats will need to be somewhat tempered due to the veto power held by the Governor. Both will work alongside new leadership in the Assembly, including Speaker-Designate Steve Yeager, Democrat from District 9 in Clark County and new Republican Minority Leader Heidi Seevers Gansert in the Senate.

And there was change in the representation of Churchill County after the November elections. Assemblyman Greg Koenig replaces now State Senator Robin Titus who replaces outgoing Senator James Settlemeyer (term limited out) who was recently appointed by Governor Lombardo as director of the state's Department of Conservation and Natural Resources (DCNR) in a somewhat controversial move as the state Constitution prohibits state lawmakers from taking certain civil jobs – including jobs created while they remain in office and those that were subject to a pay raise approved by lawmakers. That prohibition lasts up to one year after they leave office. Though the directorship of the DCNR has existed since the agency's creation in the late 1950s, the Legislature increased salaries for department leaders from 2019 to 2021 – potentially putting Settlemeyer's appointment in conflict with the constitution.

Incoming Republican governor Joe Lombardo will have \$325.8 million more in state revenues to work with over the next biennium, compared to 2021-23. Lombardo will ultimately be responsible for setting the direction of the state's finances, and will need to work with a Democratic majority in the legislature. Democrats maintained – and even increased – their majority in the Assembly and Senate during the 2022 Election, and the party has also re-appointed Nicole Cannizzaro as Senate Majority Leader, a position she also held last session.

Women once again are leading the charge in Nevada. Nearly 59% of elected legislators are women, and women have been chosen as chairs for nine of ten committees in the Assembly, and six of ten in the Senate.

The single most important work of the legislative session is determining the state budget over the next two years. Governor Lombardo's Budget can be found here: https://www.leg.state.nv.us/Session/82nd2023/Budgets/Official%20Executive%20Budget_2023-25.pdf

Newest Commissioner Eager to Serve

Churchill County's newest commissioner is a fourth-generation farmer with deep roots in the community.

Myles Getto wanted to have a hand in shaping not only his future but the future of the county that has been such a big part of his family's lives for generations. So, at the urging of his uncle, he decided to run for office to make decisions now that young folks like himself could enjoy for many years.

"If I ran for office later in life, the decisions I'd make wouldn't affect my life," he explained.

Getto is looking forward to representing agriculture producers on the commission and bringing his water background and knowledge to the table. He served on the Churchill County Planning Commission for three years where he said he learned a tremendous amount about the lives of local citizens before deciding to run for the commission. "I saw I could make a difference," he said.

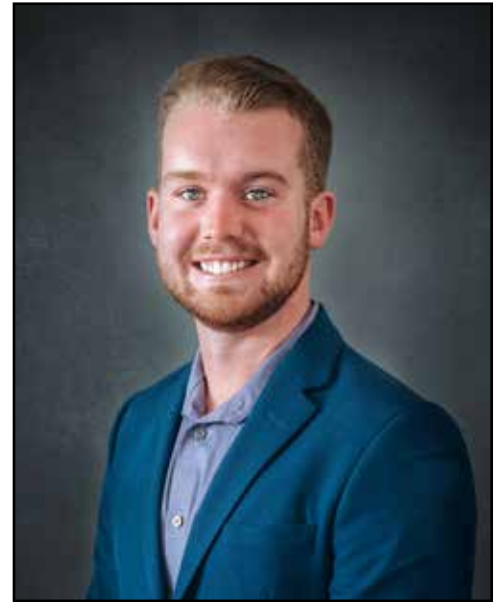
He is looking forward to working on issues with the Navy, especially the rela-

tionship between ag producers and the Navy. Getto also looks to his work with the Central Nevada Regional Water Authority and ensuring access to water to those downstream on the Carson River. Myles' family settled in Churchill County in the early 1900s, coming from Italy.

"I am farming the same land they put into production all those years ago," he said. The Getto farm, which grows alfalfa and teff, is located on the Lovelock Highway and may be best known in recent years for Fernando, the llama who lived in the roadside pasture for several years. Biscotti, the foal, and JW, the donkey, now occupy that space, said Getto.

An avid FFA and 4-H student while attending Churchill County High School, those experiences further developed his agricultural interests and afforded him opportunities for travel, representing the scope and operations of a large ag business in the United States.

At the age of 17, he was one of 20 FFA students nationwide who went to Washington, DC to represent U.S. agriculture to developing countries. A year later, he went to the U.S. Virgin Islands to advise



the horse racing industry there on best practices for growing hay and forage. Getto is an avid fisherman who enjoys bass fishing in Dixie Valley. He also loves pickleball and has traveled across the country doing so.

Law & Order

Law and Motion from District Court

The Tenth Judicial District Court convened Tuesday, January 31, Judge Thomas Stockard presiding.

Darren Shane Frisby appeared for sentencing on a Category D Felony of Possession of a Schedule 1 or 2 Substance for the Purpose of Sales. Fees and assessments were imposed, and Frisby was sentenced to 12-36 months in Nevada State Prison, suspended, and placed on probation for 24 months. He was ordered to get a substance abuse evaluation and to follow the recommendations of the evaluation. Other standard conditions of probation were imposed.

Aaron Wendell Denshire, in custody, pled guilty to a Category E Felony of Possession of a Controlled Substance 1st or 2nd offense, which is punishable by a possible 1-4 years in Nevada State Prison and a fine of \$5,000. Fees and assessments were imposed, and Denshire was sentenced to 12-36 months in Nevada State Prison, suspended, and placed on probation for 18 months. He was ordered to get a substance abuse evaluation and to follow the recommendations of the evaluation. Other standard conditions of probation were imposed.

Casey Ryan White, in custody, pled guilty to a Category B Felony of Driving while under the influence of intoxicating liquor or controlled or prohibited substance causing death or substantial bodily harm, which carries a potential penalty of 2-20 years in Nevada State Prison and a fine of \$2,000-\$5,000. This charge carries a mandatory prison sentence. A Pre-sentence Investigative

Report was ordered and sentencing was set for April 25.

PD Wright Noel addressed custody status, asking that White either be released on his own recognizance or that bail be reduced to \$1,500. Noel said the defendant has potential employment and would like the chance to save a little money for when he gets out of prison. ADA Lane Mills said the state's biggest concern is that of public safety. White's blood alcohol was .17 and there was substantial bodily harm caused. The judge lowered bail to \$1,500 and told White that if he does post bail, the conditions of Court Services supervision with daily check-ins and random testing, a SCRAM device, and standard conditions would apply.

Christy Lynn Mullins, in custody, appeared for two sentencing violations. PD Jacob Sommer told the court that Mullins has other charges pending in Justice Court and requested a 2-week continuance. The judge granted a continuance to February 14.

Darren Neil Albury, in custody, appeared for a non-technical probation violation of Absconding, and sentencing on a Category E Felony of Possession of a Controlled Substance which he pled guilty to in District Court on January 17. The judge ordered a Pre-sentence Investigative Report and set disposition for April 25.

Tyler Reese Nikonowicz was not present for a Judicial Review regarding competency as he has been committed to Lake's Crossing. The judge stated two doctors say there "is not a substantial probability that Mr. Nikonowicz will be

able to be treated to competency." ADA Mills told the court that given the findings of the two evaluations, it is a matter of law that the case is dismissed. PD Noel had no objection. The judge found the defendant to be incompetent and ordered the case dismissed.

Jillian Olivia Yesslith, in custody, pled guilty to a charge of Grand Larceny of Personal Goods or Property in the amount of \$1,200 - \$5,000. This charge can be tried as either a Gross Misdemeanor, with a possible penalty of 364 days in Churchill County Jail, or as a Category E Felony with a possible penalty of 1-4 years in Nevada State Prison. The judge ordered a mental health evaluation and a substance abuse evaluation be done and continued the case to February 28. Court Appointed Attorney Kyle Edgerton addressed custody status asking that Yesslith be released on her own recognizance. After discussing several points with counsel and with the defendant, the judge ordered OR to commence on February 7 with the condition of supervision by Court Services, and other standard conditions.

John Paul Markowski pled not guilty to a Category B Felony of Assault with a Deadly Weapon, which carries a potential penalty of 1-6 years in Nevada State Prison and a fine of up to \$5,000. Markowski's attorney, Steve Evenson, requested a settlement conference take place before a trial date being set. ADA Priscilla Baker stated 3 to 4 days would be necessary for a trial. The judge ordered a settlement conference be scheduled.

Notes from Justice Court

The New River Justice Court convened Monday, January 30, Judge Ben Trotter presiding.

Joe Schilder, in custody, pled not guilty to charges of 1) Driving Under the Influence, 2nd offense, 2) No tail lamp, and 3) Failure to Maintain Lane. He was found to be public defender eligible, and one will be appointed. Status Hearing was set for February 2.

Debbie Kaye Campbell pled not guilty to a charge of Battery. A trial was set for April 18.

Fausto Ramirez-Barajas pled not guilty to 1) Driving Under the Influence, 2nd offense, and 2) Driving with Revoked Driver's License. He was found to be public defender eligible, and one will

be appointed. Status Hearing was set for February 2.

Simi Sappa appeared for sentencing on a misdemeanor charge of Failure to Yield for a Stop Sign. Rebecca Youngman was present and made a victim impact statement. Youngman has accrued thousands of dollars in medical bills stemming from the incident. As Sappa's insurance has made payment, and Youngman has retained a civil attorney, restitution was not ordered today. The judge fined Sappa \$115.

Joe Schilder, in custody, pled guilty to a second offense of Driving Under the Influence. A substance abuse evaluation was ordered. A Status/Sentencing was set to be held in three weeks.

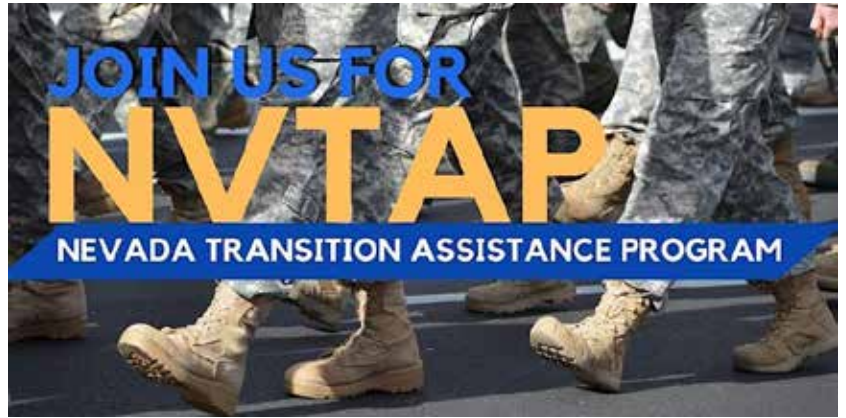

Cursive and Life Skills Taught in the Classroom

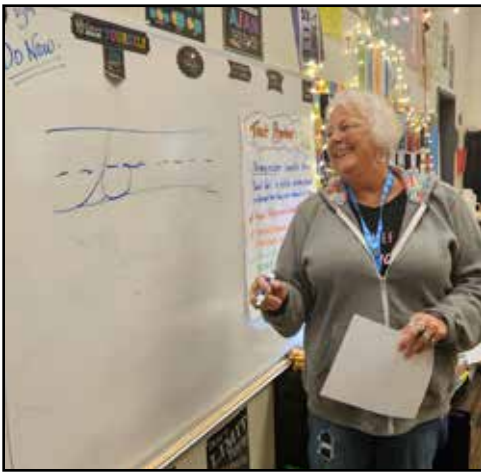

What's Cookin' in Kelli's Kitchen -- *Pasta Postulate*

Writing weekly for "The Fallon Post" has initiated an interesting component in my daily life. At least 4 times a week, I have a conversation with someone about this article, what I am cooking, or just that they recognize my name or picture from the paper.

It happened this week at Bassham Furniture when I was replacing a poorly engineered bedframe. A few weeks ago, it happened when I was talking with the interim head of the department in which I am enrolled at Western Nevada College. At the Library Board of Trustees meeting in December, I was cornered by my new friend Mel who wanted to talk pot roast.

Mel is the (relatively) new director of the Churchill County Museum. He and his spouse have not been in Fallon nearly as long as I have been writing this article so I wasn't surprised when I realized that the method he described for making pot roast was one that I had written about in a past article. Mississippi Pot Roast will forever live as a recipe of significance for me because it was the first recipe that a member of the general public told me that they attempted after reading about it in my article. In fact, every time I bump into Alan Kalt, he tells me again that they make Mississippi Pot Roast several times a month.

So in honor of my new friend Mel and my longer-time friends The Kalts, here is an excerpt from "What's Cooking in Kelli's Kitchen" as published on January 27, 2021.

Neil and I wrapped up our weekend with another internet sensation--Mississippi Pot Roast. If you have never experienced it, Mississippi Pot Roast is a dish that sounds terrible on paper but is delicious when concocted. Chuck roast, pepperoncini (with juice), Ranch dress-

ing mix, a packet of powdered au jus mix, and a nug of butter all slow-cooked in the crockpot (or rushed in the instapot for those late afternoon cravings). You can serve it over mashed potatoes, shredded on a crunchy loaf of bread, or just eaten like stew out of a bowl. Midwest 1980s cooking at its finest and definitely a keeper in our kitchen rotation.

Mississippi Pot Roast

(adapted from someone somewhere who had a seemingly terrible idea that ended up working out in an epic way)

Ingredients:

1 chuck roast - doesn't matter how big or which particular type
1 jar of pepperoncini with juice (something magical happens to the peppers when they mix with the juice so you might want a second jar if your roast is large or you particularly like peppers)
1 packet of dry au jus powder (can substitute beef gravy mix or beef consommé powder)
1 packet of dry Ranch dressing seasoning
1 stick of butter (this dish is pretty salty, so I suggest using unsalted butter)

Directions:

1. To cook in a crock pot: put your pot on low, plop in your chuck roast, sprinkle both flavoring packets over the top of the roast covering as completely as possible. Dump in the jar (or 2) of pepperoncini with all the juice. Top with the stick of butter, cover, and walk away. Your roast is finished when it has reached 185 degrees, is easily shreddable with a fork, and when you are ready to eat. On high heat, plan on 5-6 hours of cooking time or 8 hours on low.
2. To cook in an insta-pot: Add all in-

gredients in the order described above. Cook on the "meat" setting for at least 45 minutes under pressure. Natural release and enjoy.

Stove/Oven Directions:

1. Preheat oven to 300°
2. Season meat well with salt and pepper. Heat 2 T of olive oil in a Dutch oven over medium-high heat. Sear meat well on at least two sides. Add the remainder of the ingredients and bring to a simmer. Cover and place in the oven for at least 4 hours. Check temperature periodically. When the roast has reached 185° and is easily shreddable you are ready to go.

This title is available in print at the library, downloadable eBook through Overdrive/Libby, and as downloadable audio via hoopla.

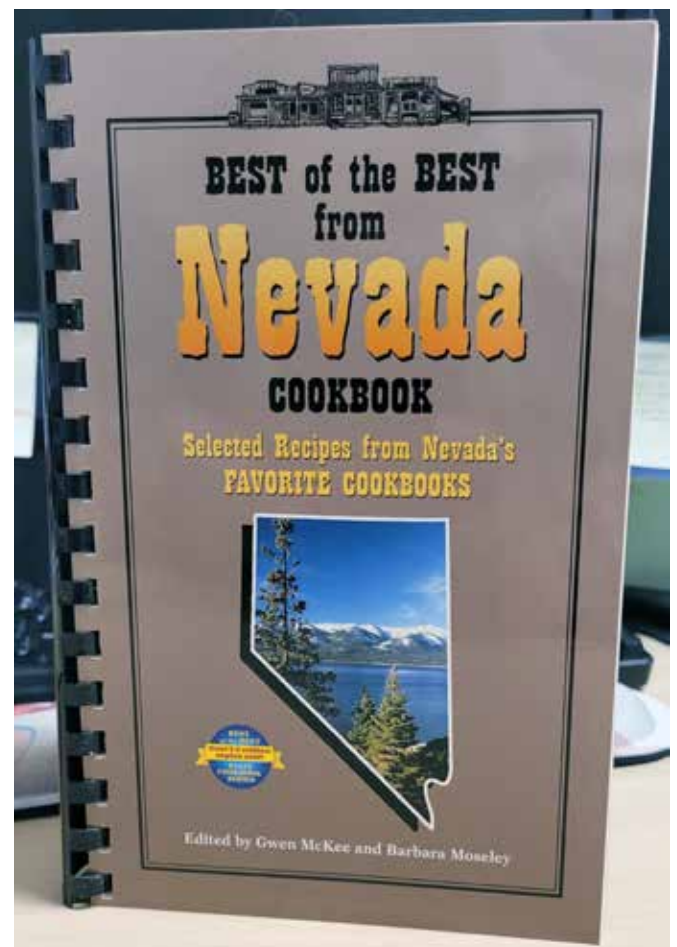

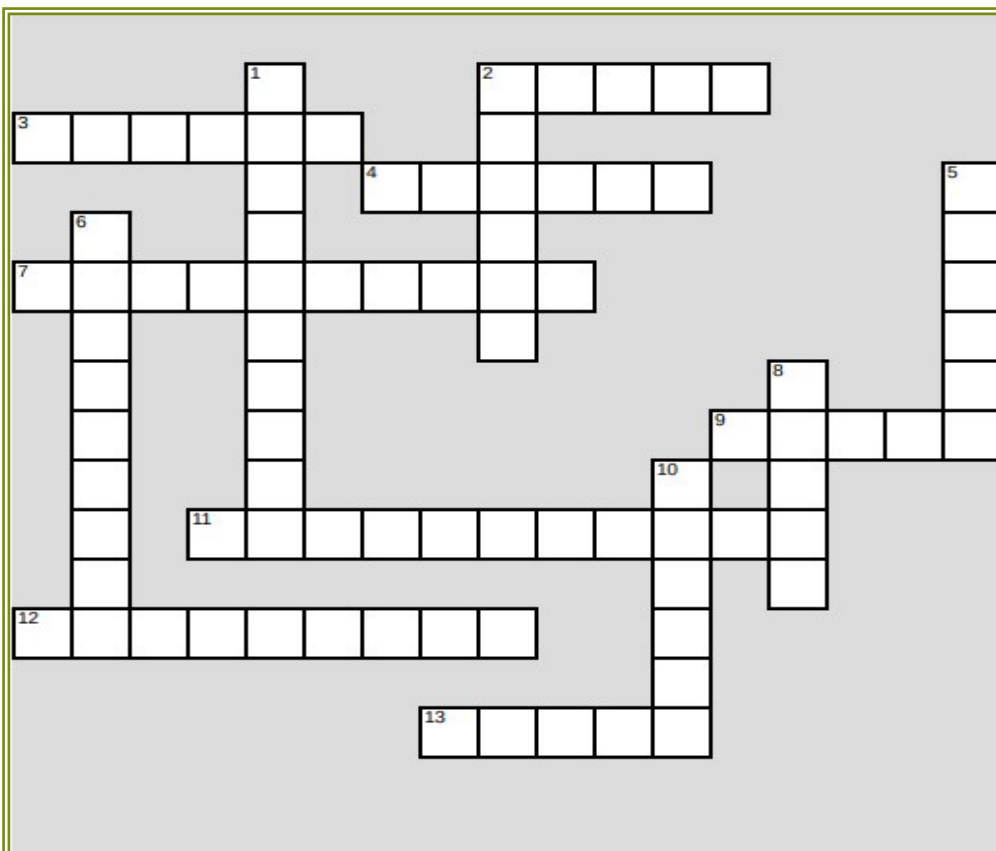
