Mosquito Mania - Steps to Prep Part III

When driving west on Reno Highway, one might easily overlook a building marked "Churchill County Mosquito, Vector & Noxious Weed Abatement District" when in fact, this is a dedicated group of county professionals, facing an important task this season.

"This unprecedented water year has brought a heightened breeding ground of standing water, which enhances the increase for various bugs, but especially mosquitoes. Our office will be running service calls and working standard rotations to necessitate the state-controlled standards and Department of Agriculture's compliance levels, on behalf of mitigating mosquito control and abatement within our county region," stated Nancy Upham, District Manager, who holds a degree in entomology and other specialized sciences.

The five-member Board of Trustees, along with Upham, Assistant Manager JD Mackay, Board Secretary Melania Sagi, and Legal Counsel Joseph Sanford, met on May 11, 2023,

to finalize logical strategies, efficiency standards and procure equipment that can overcome some recent hurdles and strengthen the overall future of the department.

One hurdle was losing the air application sprays, previously contracted to a local pilot who has since retired. To regain necessary land access for pesticide coverage, the department added a new Backwater Airboat to navigate backwaters, marshes, or shallow water use. To maximize this purchase, the board of trustees also authorized a Memorandum of Understanding that the airboat could have shared use with the Churchill County Sheriff's Office, should it ever be needed to assist in a water rescue, investigation, or enforcement operation.

To manage the mosquito callouts and applications required, other measures included the purchase of several additional foggers and pesticide applicators that can be truck or trailer mounted. With trained technicians calculating zoned areas, which include agricultural lands, acreage, and

residential developments, consistent monitoring is required. This busy staff continues to work efficiently, attempting to remain ahead of the expected mosquito outbreak season. As stated in a printed update, over 177 acres of

source area were already treated with various larvicides by the first week in May.

Update on Local High-Water Mitigation Projects

As the weather warms up, local officials continue high-water mitigation efforts to proactively address the potential for flooding in the coming months to safeguard the community.

The City of Fallon and Churchill County are completing preparations to safeguard wastewater and water treatment facilities and urge residents and businesses in flood-prone areas to sandbag their cleanout vents to reduce the risk of compromised systems should a high-water event occur. Restaurants and businesses with grease interceptors should sandbag around those fixtures for the same reason.

The second weir's construction is on track for completion around May 19 on the V-line canal adjacent to the 2017 weir. Water will start flowing through the new weir shortly after completion.

A berm along Pasture Road has been completed to increase the water storage capacity in the Carson Lake Pasture east of U.S. Highway 95 south of town.

There are free, pre-filled sandbags available for pick-up at 485 Miner's Road, by the fairgrounds, on Mondays from 1-4 p.m.

Sandbag delivery is available upon request by contacting the High-Water Call Center at 775-867-5923 and leav-

ing a message. Delivery is available for all members of the community who have mobility challenges or are over 60 and live along the Carson River.

Calls will be returned on weekdays from 11 a.m. to noon and 3-4 p.m. to schedule the delivery.

to be an important one for humans and animals, as they boldly use statements such as “combatting with prevention” and “attacking these blood-sucking insects.” A no-charge service visit is available, should you have any questions about excessive mosquitos. You may call their office during standard, weekday hours at (775) 423-2828. It is not necessary but may be helpful if you know the possible source of standing water, which could be as simple as an old tire corralling stale water, creating an egg-laying habitat.

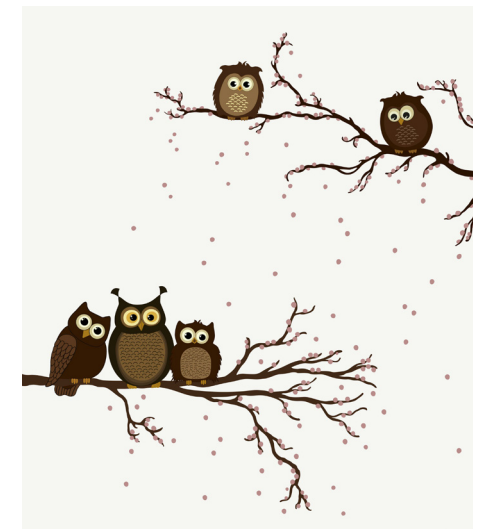
Upham stated, “Any standing water is a risk, so we want to come out and spray, as mosquitos will lay hundreds of eggs in standing water the size of a hoof print, or in wet grass islands, backyard ponds, and all murky places. They quickly develop into full-sized mosquitos in just 5-10 days.”

Upham presented a helpful brochure and is devoted to developing and maintaining a monitored program for immature and adult mosquito populations and disease control, which included monitoring birds and surveillance procedures.

Residents are encouraged to dump water from old buckets, water-filled containers, and backyard toys, and eliminate all stale, standing water sources. The department also schedules fogging or spray methods, based

on limited barometric time frames, atmospheric winds, and other critical restrictions, which equates to technicians sacrificially working various scheduled hours that will accommodate the best coverage and long-term effects.

“Remember that mosquitos are not respectful to property lines and will travel from 300 feet to 300 miles, so we should all do our part,” said Board Secretary and Office Manager, Melania Sagi.



Fallon Paiute Shoshone Tribe Partners with UNR to Help Victims of Violence

Did you know that Native Americans experience a higher prevalence of family violence than any other ethnic group in America? Were you aware that Native American women are more likely to require medical attention after an assault, sexual or otherwise? Or that Native American women over 18 are sexually assaulted more often than other groups? Or is there a higher likelihood of firearms and substance abuse in these types of crimes?

While this data is disconcerting, it can be crucial to raise awareness and find ways to address the myriad of systemic hardships that have plagued Native Americans for generations. Fortunately for the Fallon Paiute Shoshone Tribe (FPST), an alliance with the University of Nevada Reno is helping bring information to light that may help the victims in this generation and the next move away from the cycle of violence.

Over the past few years, UNR and the FPST Victim Service have been working together to better understand domestic and family violence among tribal members. The first step in this process was conducting a comprehensive needs assessment in 2015. According to Victim Services Director Michelle Bowers and UNR Professor of Counseling Brenda Freeman, Ph.D., this has been no small feat. “It’s hard for victims to talk about this,” said Bowers. Victims often don’t even want to use our services.” Statistically, most crimes of violence, on and off the reservation, are perpetrated by family members, a former or current intimate partner, or a close friend. This means it is not just a “violence” problem but a family and cultural one. As a result, something that is extremely difficult to talk about becomes nearly impossible.

According to data from the 2015 needs assessment, FPST members have experienced or are experiencing:

- 53% - verbal or mental abuse, being forced into illegal actions,

personal property damaged or destroyed, compared to 50% nationally

- 39% - threats by a romantic partner with a weapon compared to 34% among other American Indian/Alaskan Native Tribes (AI/AN).
- 38.7% - severe physical violence compared to 24.3% nationally
- 28.8% - choking or strangulation compared to 30% nationally
- 27% - forced engagement in sexual acts they did not want compared to 9% nationally
- 36% - money withheld, being kept from employment, or property sold or stolen by a romantic partner
- 17% - as a child being hit, slapped, pushed, or shoved by an adult
- 18% - as elderly tribal members, not permitted to make their own decisions (11% are currently experiencing emotional or verbal abuse, 2.5% are being physically abused, and 41% are supporting someone else financially)

According to the data, the Fallon Paiute Shoshone Tribe reports a higher rate of victimization than national averages and those of other AI/AN tribes. “New data will give us a better comparison,” explained Freeman. “We have to have enough surveys to get good sample data.”

The first needs assessment gave the tribe and UNR a foothold for revamping the FPST Victim Services program, which does not only help victims of domestic violence but any crime committed against tribal members. Interestingly, the Fallon Tribe is the only tribe in Northern Nevada that has established such a collaboration with the university. In fact, at the National Conference for Victims of Crime, the FPST-UNR partnership was acknowledged for being the only collaboration of its kind.

The current needs assessment is collecting data on its third round of double-blind surveys. Surveys were mailed to tribal members; however,

it can be challenging for victims to respond in homes where violence occurs, even though the surveys are anonymous. And the survey is not just for women; men were also asked to respond, as men of all ages can also be victimized.

According to Freeman’s research, the data demonstrates a shared experience among all American Native/Alaskan Native tribes - lateral violence within the community. This lateral or displaced violence is anger and rage expressed toward families and peers rather than toward the oppressive adversaries that placed them on reservations. This trauma – and the response to it, have become a multi-generational norm. Thus, the violence is continually perpetuated.

Complicating matters are a lack of confidence in the judicial system and regional isolation; therefore, many victims do not receive services or report crimes committed against them. For communities in remote areas like the Yomba Shoshone Tribe, law enforcement response can take as long as four hours. Immediately after being abused or assaulted is the most critical

time for victims. Why report the event when potentially worse things can occur while waiting for help? Unfortunately, tribal communities experience higher rates of violence while receiving fewer services from law enforcement, hospitals, clinics, emergency housing, etc.

“This partnership is a priority for the university,” said Freeman. “The provost, Bill Thompson, is very supportive of community partnerships. We realize that while they take a lot of effort, there is value in a good partnership.” Not only does this partnership help the tribe assess need, but it also helps bring in grant funds that will directly benefit victims and significantly improve the services they can receive. As a bonus, UNR students and staff can often go beyond the academic and put the data to real use on the ground.

FPST Victim Services will continue its partnership with UNR and its efforts to provide services to victims of crime. Emergency services for victims of crimes can be accessed through the FPST Victim Services crisis hotline at 775-427-0985.

Special Events Come to the Cantaloupe Festival

Cantaloupe Festival organizers continue to build and expand Nevada's longest-running agriculture celebration as they head into the 38th annual event this August 25 – 27.

On top, this year is a rodeo on Saturday night, which will run from 6 p.m. to 8 p.m., followed directly by a concert in the 3C Arena featuring Ned LeDoux, son of famous country music star Chris LeDoux.

Noel Lambert is heading up the committee for the rodeo and has big plans. The rodeo has been sanctioned through an amateur rodeo circuit, California Cowboys Professional Rodeo Association, and has also applied for sanction rodeo by the Idaho Cowboys Association. "Hopefully, within the next three years, we will have a pro rodeo; that's our goal," she said.

The event will draw contestants from Idaho, Oregon, California, and Nevada.

There will also be junior rodeo

events, with a contest on Saturday morning, August 26, at 8 a.m., with 20 contestants for each event, including steer, sheep, calf riding, and barrel racing. The top five of each event will return to the performance that night. "We want to get these kids involved in rodeo and spark that interest."

Ned LeDoux will headline the Saturday night concert at roughly 8 p.m. after the rodeo. He has been playing music since he got his first drum set at the age of five and joined his father's band as a pinch-hitter at 21 when their drummer, KW, was in a car wreck. He has toured with groups like Sawyer Brown, Toby Keith, and Garth Brooks. LeDoux is playing at the Ryman Auditorium in Nashville this week and will make his way across the country all summer, playing the top festivals and fairs before landing late summer in Fallon.

The rodeo is included in the general admission festival ticket cost, and the concert will be an extra ticket,

The long-awaited Grid Market and Brewery opened Thursday, May 18, at 2030 Reno Hwy., featuring an open-concept indoor market showcasing the taproom and brewery. This community-oriented facility brings together the best of Fallon's own locally brewed beer, retail, and food in a one-stop social shop.

It is not meant to replace The Grid Brewpub on Taylor Place but rather to add to the area a new and exciting way to spend an evening or a beautiful Fallon afternoon.

Owners Paul and Tiffany Picotte have invested much time, energy, and money into this new establishment. Paul said: "I may not be from Fallon, but I believe in Fallon and want to invest in Fallon. This is my home town." Tiffany agreed.

Upon entering the brewery you'll find a large wide-open space with long wood slab tables and matching chairs on a glossy floor that make it very inviting and friendly. To the right are three markets matching the overall

Western theme of the place. The first is a Whiskey and Wine store where you'll find high-end beverages which can be purchased by the bottle or by the glass. Lockers are available for a fee to store your whiskey or wine bottle for a later visit. In the second space is a Western-style apparel, jewelry, and other items store. The third part of the market is a home décor store.

In the front left of the building is the Poke Bowl café. Featuring fresh "island style" poke bowls. You'll have to try it to believe it.

There are pinball and other amusement machines including an old-style shuffleboard game. Finally, in the very back is the actual brewery which you can see from the new bar. 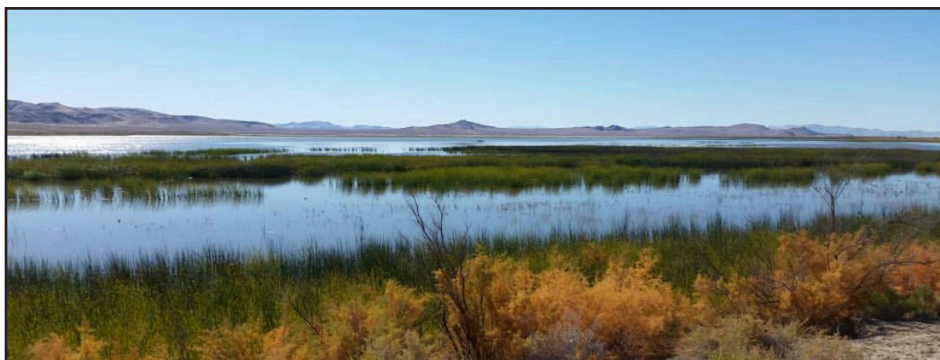

Law & Order

District Court Report

The Tenth Judicial District Court convened Tuesday, May 9, Judge Thomas Stockard presiding.

Aaron Michael Randall pleaded guilty to the Category B Felony of Attempt to Commit Unlawful Use of a Minor less than 14 years of age in Producing Pornography or as a Subject of Sexual Portrayal in Pornography which carries a potential penalty of 2 to 20 years in Nevada State Prison. Prison time is mandatory unless the defendant completes a psycho-sexual evaluation and is found to not be at high risk of reoffending. Randall must register as a sex offender. A Pre-Sentence Investigative Report and a Psychosexual Evaluation were ordered. Sentencing was set for August 15.

Tad Fredrick Mergener appeared via Zoom from Michigan without the court's permission to do so. Mergener told the court he had a mental breakdown and was out in the desert for seven days. His family and friends took him to Michigan where he is living with his parents. Chief Deputy District Attorney Lane Mills stated Mergener was released on his own recognizance and has not complied with court orders and asked for a Nevada-only Bench Warrant. Stockard so ordered.

Henry Allen Camacho, in custody, was sentenced on the Category B Felony of Robbery. Stockard honored the negotiations in the plea memorandum, and the desire of the victim as he sentenced Camacho to 72 – 180 months in Nevada State Prison, suspended. The defendant was placed on probation for 36 months provided he entered and complete the Western Regional Drug Court program, and mental health court if deemed needed, along with standard conditions of probation. Camacho was released so he could meet with Social Services and get started on setting things up. He was ordered to be at drug court May 10. Fines and assessments were imposed.

Georgina Lynn Brown, in custody, was granted a one-week continuance at the request of her attorney, Jacob Sommer.

Shelley Leanne Sonafrank, in custody, admitted to a Court Services violation. Brenda Ingram, Director of Court Services, told the Court that Sonafrank is generally cooperative, nice, and polite, however, she's having a hard time following the rules. This is her 4th violation in 5 months. Ingram reminded Judge Stockard told Sonafrank at her last violation hearing he would set bail at \$50,000 cash if she violated again. Following statements from attorneys, bail was set at \$50,000 cash.

Darian Michael Newman, in custody, was granted a one-week continuance as his attorney William Routsis is ill today.

Ryan Edward Street, in custody, admitted to a non-technical probation violation involving a controlled substance, and new criminal charges. Disposition was set for May 16.

Jonathan Anthony Taylor, in custody, admitted to non-technical probation violations related to reporting, intoxicants, employment, and new felony charges in Lyon County. After sharing the defendant's extensive criminal history from 2015 to present, CDDA Mills asked that probation be revoked to protect society from the defendant's actions. Public Defender Wright Noel explained that the new felony was reduced to a gross misdemeanor and the defendant received probation on that charge. Noel also told the court that Taylor has a job lined up in Fernley, he has been working to get housing, and "he has a plan." Stockard revoked Taylor's probation and imposed the underlying sentence of 24 to 60 months in Nevada State Prison on the Category B Felony of Failure to Stop on the Signal of a Peace Officer, and 12 to 30 months (to run concurrent) on the Category D Felony of Failure to Appear. Taylor received credit for 157 days served and was remanded to the custody of the Churchill County Sheriff for imposition of the sentence.

Chris Lee Rudisill, in custody, pleaded guilty to Gross Misdemeanor of Violation of a Protective Order. Stockard sentenced Rudisill to 364 days in Churchill County Jail, suspend-

ed. Rudisill was placed on probation for 12 months. In addition to standard conditions, he was ordered to complete an Anger Management course within the next six months and to have no contact with the victim. Fines and assessments were imposed.

Pascual Reyes-Muniz, in custody, pleaded guilty to the Category A Felony of Sexual Assault on a Child under the age of 14. This is a charge from 2007 as the defendant was extradited from Mexico earlier this year. Stockard explained this charge "has one penalty, and one penalty only." As the felony was committed in 2007, the sentencing guidelines from 2007 carry the potential penalty of life with the possibility of parole after 20 years in Nevada State Prison. If found guilty he must also register as a sex offender and have lifetime supervision by Probation and Parole. A Pre-Sentence Investigative Report was ordered, sentencing was set for August 15.

Jose Francisco Barajas-Ramirez, in custody, pleaded guilty to the Category B Felony of Attempt to Commit Sexual Assault which carries mandatory prison time of 2 to 20 years in

Nevada State Prison. If found guilty, the defendant will also be required to register as a sex offender and have lifetime supervision by Probation and Parole. A Pre-Sentence Investigative Report was ordered and sentencing was set for August 15.

Boldragon Plexico, in custody, pleaded guilty to Battery with Intent to Commit Burglary, which is a Category D Felony, carries a potential penalty of 3 to 10 years in Nevada State Prison, and a fine of up to \$10,000. A Pre-Sentence Investigative Report was ordered, and sentencing was set for August 8. Stockard denied PD Jacob Sommer's request that Plexico be allowed to enter the Salvation Army Program based on the defendant's history of violence as requested by CCDA Mills.

Local Woman Charged with Embezzling Over \$50K from Cub Scouts

Debra Jean Lund is facing felony embezzlement charges of \$25,000 or more but less than \$100,000 after allegedly siphoning monies from the local Cub Scouts between November 12, 2017, and July 31, 2022.

According to the criminal complaint, Lund did "unlawfully, while being a bailee of money, goods, or property, convert \$50,199.49 to her use with the intent to steal or defraud the owners, while being an agent, manager, or clerk of an entity in which money, property, or effects have been deposited or entrusted." The charge is a Category B felony and carries a

potential penalty of 1-10 years in the Nevada Department of Corrections and a fine of up to \$10,000.

On February 15, a summons was filed petitioning Lund to appear in Justice Court before Judge Benjamin Trotter for an April 10 arraignment. However, the matter was continued to May 10, then again to July 13 at 8:30 a.m.

Reno attorney Paul Wolfe, Esq., represents Lund, who waived a formal arraignment.

All persons facing criminal charges are presumed innocent until proven guilty. Allegations or charges filed do not constitute guilt.

Baseball Exceeds National Averages

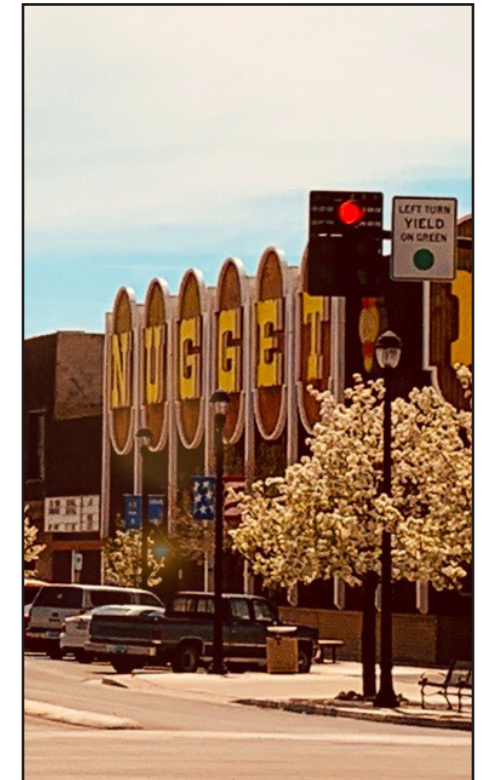

What's Cooking in Kelli's Kitchen - *Red Curry Paste*

One of the tactics that I regularly employ in the kitchen is to take something store-bought and kick it up a notch by adding some extra love. Making spaghetti sauce is not a binary choice between a day spent in the kitchen stirring a scratch-made masterwork or picking a jar of Ragu and dumping it into a pot. I will often meld the two approaches by classing up a pre-made sauce by adding scratch touches of my own—sautéed onions and garlic, a dash or two of soy sauce, some finely chopped anchovies,

shredded carrots, a mound of fresh herbs, and ample parmesan take store-bought sauce and elevate it to the next level.

This weekend, I applied that same tactic to Thai-style curry. Neil wanted Asian noodles but no peanuts. I wanted scratch-made curry without having to break out my mortar and pestle, not to mention trying to find all of the specialty ingredients that provide the layers of flavor, some of which likely necessitate a trip to Reno. Instead, I doctored up a jar of premade red curry

paste with a variety of additions, all of which were readily available at a local grocery. I added in a bounty of produce, some noodles, and a handful of fresh herbs, and dinner was done.

Here are a couple of recipes that start with a pre-made product and step it up a notch.

Red Curry Paste

INGREDIENTS:
 1 bunch cilantro
 2 cloves garlic
 1 shallot, sliced
 1 hot chili, seeded and chopped
 2 T prepared red curry paste
 1 T coconut oil
 1 T grated ginger
 2 lemongrass stalks, outer leaves removed and chopped
 Zest and juice from 1 lime
 2 t fish sauce
 1 T curry powder
 ½ T cumin seeds
 1 t ground coriander

DIRECTIONS:

1. In a food processor, combine cilantro, garlic, shallots, chili, red curry, coconut oil, ginger, lemongrass, zest and juice, fish sauce, curry powder, cumin, and coriander. Blend into a paste, scraping down the sides of the blender as needed. If the mixture is too thick to blend, add a teaspoon or two of water as needed.
2. Store the finished paste in the refrigerator for up to 3 weeks or freeze for up to 3 months.

Doctored-Up Red Sauce

INGREDIENTS:
 2 T butter
 1 T olive oil
 8 oz sliced mushrooms
 1 c red wine
 1 lb ground beef
 1 yellow onion, diced
 1 can crushed tomatoes
 1 red bell pepper, seeded and chopped
 1 green bell pepper, seeded and chopped
 3 cloves garlic, minced
 2 T oregano
 2 T basil
 1 T rosemary
 1 6 oz can tomato paste
 1 jar spaghetti sauce

DIRECTIONS:

1. Melt butter with olive oil over medium-high heat. Add mushrooms and cook until browned. Add in ½ c red wine and bring to a boil. Reduce heat to medium-low and simmer until reduced by two-thirds (about 10 minutes).
2. In a large pot, brown ground beef with the onion, bell peppers, and garlic stirring regularly (about 10 minutes). Add crushed tomatoes and dry spices.
3. Stir in ½ c red wine and tomato paste. Add jarred spaghetti sauce. Bring to a simmer, stirring regularly, and let cook for about 20 minutes. Add in the mushroom mix and serve over pasta noodles.

Allison's Book Report - "Happy Place" by Emily Henry

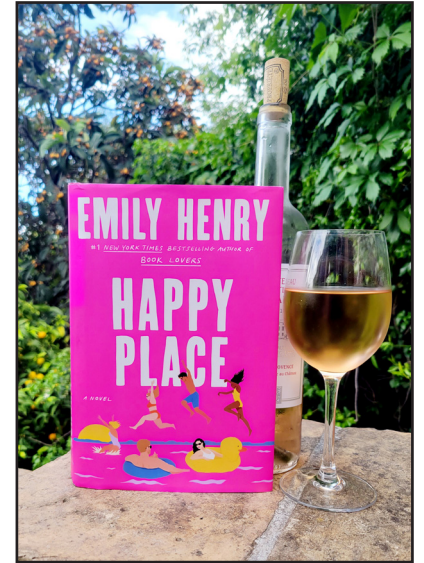
